TRANSPORTATION REQUEST FORM STUDENT DRIVING/RIDING CONDITIONS

Transportation is provided for students enrolled in the Career-Technical Education Programs of the Six District Educational Compact. It is expected that students will use this transportation system. Permission to drive/ride may be granted under the following conditions. However, should a student have a need to drive/ride to school; to the worksite; or to a worksite visitation (field trip), this form must be completed.

CONDITIONS

PARKING PERMIT WILL BE HELD UNTIL PAST DUE SCHOOL FEES ARE PAID OR PAYMENT PLAN IS AUTHORIZED.

1. Class schedules are incompatible with the Six District Educational Compact bus schedule. Due to a few unique Career-Technical Education Programs, it may be necessary for students to drive.
2. These conditions also apply to Worksite Visitations (field trips) that are in close proximity to the student's own community.
3. Students participating in "Early/Advanced Placement," capstone experiences and/or internships/mentorships may have a need to drive to the worksite.
4. The student's parent/guardian approves the request to drive/ride.
5. The sending school principal/designee approves the student's request to drive/ride. (A parking pass from the home school is acceptable approval.)
6. Students will pay a "one-time" parking fee to either the sending school or to the receiving school. Proof of payment will be required (receipt or presentation of home school parking pass). Bring with you when you return the form.
7. No student shall drive, park or ride without approval from their parent/guardian and without a valid reason for driving/riding.
8. The vehicle is minimally insured under the laws of the State of Ohio.
9. The driver is licensed to drive under the laws of the State of Ohio.
10. Any additional requirements of the individual school district must be honored.
